**Discussion Items**

- Crosslisting Policy Discussion (Michelle Head)

Michelle explained that this policy did NOT pass at Faculty Senate. She wants UPCC to examine the policy to ensure that it will pass when it goes up again.

**KSU Policy on Course Cross-listing**

A cross-listed course is a course that is offered under more than one prefix. It must have documentation with the Office of the Registrar and a proper description in the course catalog.<sup>1</sup>

1. Courses must be within the same undergraduate or graduate numbering level
2. Cross-listed courses must have the same credit hours and same learning outcomes. In addition, sections of a cross-listed course must have the same syllabi, which includes the same instructor, course location and time, assignments and grading scheme.

3. Special Topics courses can only be cross-listed with an equivalent Special Topics course with another departmental prefix.
4. Traditional independent study, honors thesis, practica, internships, directed study, master's thesis, dissertation courses should not be cross-listed.
5. Cross-listed courses must be supported by a rationale or justification.
6. No more than three courses can be cross-listed unless all prefixes are owned by the same department.
7. Students cannot earn credit for more than one of the cross-listed courses.

*Question: Would the courses have the same name?*

Michelle answered that she wasn't sure, even though the course has to have the same syllabus. Rebecca Hill stated that she was one of the ones who had concerns at Faculty Senate. She was curious as to why the document Michelle was sharing in the meeting wasn't identical to the documents that had been shared via email.

Heather Pincock chimed in saying that the emails contained a "Rationale" document with information that caused concern.

Rebecca clarified that the issue is that "any cross-listed courses should be permanently cross-listed in the catalog." This would impact flexibility in a negative way.

For example, in the English dept. there is a course called "Ethnic Literature". There might be different sections on *different* styles of Ethnic Literature. One of those sections *might* cross-listed with another course in another department based on interdisciplinary connections. The current Cross-listing procedures allow for that. This new policy might restrict that if it requires courses that are cross-listed to permanently stay that way. This is a common practice that would be disrupted.

Cécile Accilien (Chair of Interdisciplinary Studies) raised concerns as well. We are trying to make sure we are meeting students' needs. This policy will affect how much we have to work on justifying faculty qualifications for teaching courses. This will also cause extra labor in the area of helping students plug courses into their portfolio and where things count.

Kristina DuRocher stated they are asking for a proper description in the catalog and [we] haven't unpacked whether a "permanently" cross-listed course limits its abilities to *not* be taught otherwise. [We] just want literature in the catalog that says this course "may" be cross-listed or "could" or "has been approved to be" cross-listed.

Michelle Head added that – from the committee that created this policy – [our] objective was to clarify to students what courses fall under this option, as a way of record-keeping. These courses are currently not being tracked in the system. The data doesn't exist as to what courses have been offered in this manner.

Rebecca Hill responded that it's helpful to know that the intent is to indicate what *could* be cross-listed. That wasn't clear in the data. Prof. Hill also expressed that it would be possible to cross list a course with different courses throughout the years in an area of discipline. Amanda (Wansa Morgan) suggested in the chat that the language on the course could refer to general Prefixes over specific courses...

Rebecca Hill also asked: How is it this information is not tracked?

Amy Jones chimed in. It's not that it's not tracked in Banner – Banner can keep a record of this. The issue is that we don't have a record of what is approved and there's no vetting for that. We have no idea if these instances have appropriate faculty, resources, etc. and we have no guidelines when these courses are going through the approval and scheduling process. Amy gave some examples as to why this could be problematic and raise the questions, “do these courses actually have content that matches and how do we track that?”

Michelle Head also pointed out that there were issues with Degreeworks and being clear on what counts toward graduation. If we don't have clarity on what courses “fit” where in Degreeworks, they won't populate. There are a lot of degrees that have guided electives or related studies. If a course that's cross-listed with a course in the degree doesn't fit into the degree program, there's a lot of work that needs to happen to plug it all in.

Carmen Skaggs said that having a policy makes sense and the issues that exist need to be solved. However, there are a few of these rules in the policy that might not be necessary; can we discern what we need from this drafted policy? In her opinion, points 1, 2, 4, & 7 are fine and applicable.

Heather Pincock – RCHSS – I was a Faculty Senator that raised concern about the policy. She clarified that she is hearing three goals here – the ability to track (which we can do after the fact), the ability to check Chairs & Deans approving these courses, and transparency for students. She amplified Carmen's request to discern the necessary policy points and get rid of those that are intrusive. Maybe the answer is as simple as stating *potential* for a course to be cross-listed to students. Heather also needed clarity on why tracking wasn't possible.

Amy stated that we can get a report on which courses have been cross-listed that particular semester. It doesn't flag students to say “You've already met this requirement.”

Michelle Head asked if the Registrar can speak to how the tracking currently occurs.

Mardi (Richardson) chimed in. We are seeing students register for the wrong level of the course. Sometimes it's an undergrad vs. grad level of a course and folks are registering for the wrong level – this might be an advising issue. Michelle said that sounds like more like a “cross-leveling” issue.

Danielle added in – one area she has seen an issue in – ENGL 2002 and 2320 – they are using two different titles but teaching the same content. The student is registered for BOTH and it's not until the professor or unit is monitoring those rosters that this is problem. This is rare that this happens but it has happens. If they can use either one to satisfy an area, we need to have some indication for students as they are registering.

Amanda Wansa Morgan asked what research went into looking at policies across the USG. What do they do? What can we keep or toss from this current policy?

Xiao Huang responded that the committee studied over 20 other policies including UGA, Georgia State, and more. #3 causes the most problems for our departments and faculty concerns.

Michelle confirmed the concerns around #3, 5, and 6. Perhaps we can focus the conversation on those points?

Jeff recommended that the footnote get moved into the main body into #7. It seems like that's more critical than a footnote.

Brief discussion ensued about how this impacts Special Topics.

Carmen Skaggs pointed out that the Interdisciplinary Studies department is going to be the most impacted by this, especially the rejections to policy items 3, 5, and 6 exist. This activity is standard operation procedures for this department.

Amy wanted clarification on why there's an objection to #5.

Carmen responded – why do we need an extra process for that? Shouldn't we trust department heads to do that?

Amanda responded that it's helpful to have this on the books to ensure that folx are following policy and not abusing the ability to cross-list to solve other problems.

Point of Order- Doug wanted to know what the next steps are in order to move forward. Can we go “step by step” with each policy point and hear concerns and essentially approve points or re-writing points with concerns.

Michelle agreed that we could go through and vote each policy point.

Perhaps give members and those asked input to state: APPROVE – MODIFY – DELETE

**Michelle will send out a SURVEY regarding this option.**

Kim questioned – are any of these steps co-dependent? Answer: Not seeing as such.

Susan Vande Ven – Policy point #6. There are a bunch of courses in her area that are cross-listed. That point would really screw up those courses and the programs that they are connected to.

### **Added Agenda Item**

Michelle Head sent an email on Tuesday March 23<sup>rd</sup> with a proposed edit to the University Handbook in regards to voting membership within UPCC.

The Current language does not delineate voting members vs. Ex-Officio (non-voting) member slots. The new language would delineate.
