The waiver will be placed on the student's account for a minimum of one semester to a maximum of 12 months. The waiver may be removed at the request of KSU Journey Honors College at any time if the student no longer meets the waiver requirements set forth by KSU Journey Honors College. The student must maintain good standing with KSU Journey Honors College and hold a 3.25 institutional GPA. For the award to be renewed, the student's institutional GPA and Satisfactory Academic Progress (SAP) GPA will be reviewed at the end of the most recently awarded semester. If the institutional GPA is below a 3.25 or if the SAP GPA is below a 2.5, or if the student is no longer in good standing with KSU Journey Honors College, the student's waiver may be removed. This is in adherence to Board of Regents Policy 7.3.4.1 Out-of-State Tuition Waivers.
